02/20/2024 Annual meetings and results of vote announced

03/11/2024 BMA Due Diligence report that says they relied on the JMT inspection and DID NOT DO THEIR OWN Inspections. Page 4 BMA bullets are misleading and deceptive:

2020 ACTUAL JMT Inspection Report stated, "we recommend PLANNING for a bridge replacement AROUND 2030"

2023 ACTUAL JMT Inspection Report stated,"opinion is that it would be prudent for the Dataw Community to PLAN for and outright bridge replacement in the 10-15 year time frame". The Report also indicated that "Dataw should under go another round of spall repairs and updated Load rating analysis IN 5 YEARS"
